Dear ECRG members

Please find attached the final ECRG endorsed v5 Preamble and v5 Service Model Elements documents for Adolescent Extended Treatment and Rehabilitation Services in Queensland. Please note, endorsement was received from all ECRG members except Philip, who is on sabbatical leave - I will ensure this is noted.

A few minor changes were made for clarity and consistency to the final documents attached - these have all been highlighted in yellow for your noting, and do not change intent or the position of the statement. For example, the Tier 3 descriptor ('Statewide Adolescent Inpatient Extended Treatment and Rehabilitation Unit') sometimes used the word 'unit' and sometimes 'service'. For consistency, I changed it all to 'service', which also captures the broader function of what we have discussed for Tier 3 (ie., beds + step up/down and rehab programs).

I have been asked to send through the endorsed documents to Sharon Kelly (Chair of the BAC Planning Group) today, and will copy you in. But please let me know if you have any concerns with the yellow highlighted amendments and I will happily correct these with the Planning Group.

Your experience and knowledge has truly enriched the final documents, and thanks to you, they will provide a strong foundation for moving forwards on this very important initiative for our young Queenslanders.
