Board presentation went fine, Judi. I can brief you later.

Immediate plan is for Ingrid to draft up separate letters on behalf of Susan (for her discussions with Board Chairs) and Peter (2 separate letters. One addressed to the CEs of effected HHSs including Metro North and South, GC, Townsville and Darling Downs. The other addressed to all other HHSs), outlining our rollout plan. Both letters will emphasise that regional areas have not been overlooked due to expansion of eCYMHS. Not sure where Mater sits in all of this. We'll have to inform JO'D, but I'd rather we take on the responsibility of the Metro South AMYOS, given they'll be coming over to us in November anyway.

I will be talking informally to the Mental Health Directors. Brett Emerson has invited me last year to join their CPD group – first meeting next week. So will need to start working the room.

Board is very clear that CHQ HHS will retain the funds. Recruitment should be the responsibility of the local HHS. HHS can fight with Susan about that. I am just the messenger boy. In relation to the 6 proposed AMYOS teams:

1. 1. We should recruit for Metro North and South (provided Mater is happy)
2. 2. Cab/Red should recruit locally
3. 3. GC, T'ville and DD should recruit locally.

In relation to psychiatrist cover:

1. 1. We should recruit for 0.6 FTE psychiatrist to cover Metro North, South and Red/Cab. I'll need to talk to B Emerson, but think I can swing it. They will want to be on the panel – I can cop that.
2. 2. 0.2 psychiatrist to be recruited each to GC, T'ville and DD. Up to them. I will ask to be on the panel, though won't be a deal breaker if they resist.
3. 3. Leaves up with 1.2 psychiatry time for eCYMHS expansion. We will recruit.

Lots of lots to do to support all this.
