Subject: Followup HR mtgs with BAC staff

Hi Kerrie and everyone

It has been fed back in a recent mtg with lead clinical staff at BAC that they would appreciate meeting Kerrie face to face at the earliest possible opportunity, given Kathryn White has gone on leave. It was also noted that the HR information to date has not been consistent in content across staff, and that there is still a lack of clarity about the options and the process.

In our BAC Org Change mtg last week, we mapped out a way forward to seek clarity/approval re option of VRs. This is progressing, however, it is clear we need to update BAC staff on the process and what we are doing to seek approval. I believe MHSS Exec and HR are now clear and on the same page about the process, but we need to cascade this info down.

It is likely our BAC Staff Communique #3 will go out today or tomorrow, but it was agreed it wouldn't go into this detail. The detail needs to be delivered one on one to staff, by line managers and discipline leaders, in conjunction with HR.

Kerrie, can I suggest we go ahead and arrange the times for BAC staff to meet with you personally, with our MHSS line managers/discipline leaders supporting these meetings?
