I would like to submit these documents to the BAC Planning Group as soon as possible this week. **I will only do this with a final email from each of you (replying to all ECRG members) that states you either:**

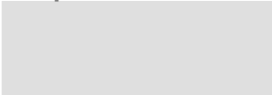
1. **endorse the document as is, OR**
