Mohan/Bill - Sharon and I have had a lengthy discussion today (before I received the above information) about the next steps with BAC. Trevor Sadler has been informed of the closure (?last week). We need to finalise (in conjunction with WM HHS) the BAC closure brief, then MHAODB will arrange a high level mtg with stakeholders to delineate alternative service models.
